Steve Good, executive director, presented the Director's Report, which included the following:

- Presentation on Five Keys Schools and Programs to new Sheriff
- Program budget updates
 - Casual Pit Stops budget increasing \$1M as of today
 - CTE pathways budget \$247,000 over 3 years
 - Juvenile Justice Social Programs \$500,000 over 5 years (support mobile school)
 - Sonoma County Horticulture \$200,000 over 3 years
 - PETS Grant \$200,000 (\$100,000 for each nav center) pet obedience training
- Home Free pushing to open in June
- IPP run similar like a grant (resource)
- WIO Grant RFP withdrawn
